In respect of consolidated unaudited interim Ind AS financial results of the Group included in the Statement, we did not review the interim Ind AS financial results and other financial information in respect of 21 subsidiaries, whose unaudited interim Ind AS financial results reflect total assets of Rs. 7,808.64 million as at September 30, 2021 and total revenues of Rs. 1,692.91 million and Rs. 3,504.13 million, total net profit after tax of Rs. 203.33 million and Rs. 414.56 million and total comprehensive income of Rs. 200.46 million and Rs. 434.84 million for the quarter ended September 30, 2021 and half year ended on that date respectively, and net cash outflows of Rs. 269.48 million for the period from April 1, 2021 to September 30, 2021 as considered in the Statement, which have been reviewed by their respective independent auditors. These unaudited interim Ind AS financial results and other financial information have been reviewed by other auditors, which unaudited interim financial statements, other financial information and auditor's

reports have been furnished to us by the management. The consolidated unaudited interim Ind AS financial results also include the Group's share of net loss and total comprehensive loss of Rs. 27.72 million and 75.29 million for the quarter ended September 30, 2021 and half year ended on that date respectively in respect of two associates, as considered in the consolidated unaudited interim Ind AS financial statements, whose unaudited interim Ind AS financial statements and other financial information have been reviewed by other auditors and whose reports have been furnished to us by the management. Our conclusion, in so far as it relates to the affairs of such subsidiaries and associates is based solely on the report of other auditors. Our conclusion is not modified in respect of this matter.
