1. Audited Financial Results of the Company for the quarter and year ended 31st March 2022.

3. Appointment of Mr. Rajeev Gupta (DIN: 00241501) as an Additional Director and designated as Non-Executive Independent Director of the Company.

The Board of Directors of the Company have appointed Mr. Rajeev Gupta as an Additional Director designated as Non-Executive Independent Director of the Company with effect from April 27, 2022, on the Board of the Company.

It is hereby confirmed that Mr. Rajeev Gupta is not debarred from holding office as Director by virtue of any SEBI Order or any other authority.

Independent Auditor's Report

To the Board of Directors of Indian Energy Exchange Limited Report on the audit of the Standalone Annual Financial Results

Opinion

We have audited the accompanying standalone annual financial results of Indian Energy Exchange Limited (hereinafter referred to as the "Company") for the year ended 31 March 2022, attached herewith, (in which are included financial results of IEX ESOP Trust (ESOP trust) being submitted by the Company pursuant to the requirement of Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations").

In our opinion and to the best of our information and according to the explanations given to us and based on the consideration of the report of other auditor on separate financial statements of the ESOP trust, the aforesaid standalone annual financial results:

- a. are presented in accordance with the requirements of Regulation 33 of the Listing Regulations in this
 regard; and
- give a true and fair view in conformity with the recognition and measurement principles laid down in the applicable Indian Accounting Standards, and other accounting principles generally accepted in India, of the net profit and other comprehensive income and other financial information for the year ended 31 March 2022.

Basis for Opinion

We conducted our audit in accordance with the Standards on Auditing ("SAs") specified under section 143(10) of the Companies Act, 2013 ("the Act"). Our responsibilities under those SAs are further described in the Auditor's Responsibilities for the Audit of the Standalone Annual Financial Results section of our report. We are independent of the Company, in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India together with the ethical requirements that are relevant to our audit of the financial statements under the provisions of the Act, and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence obtained by us, along with the consideration of report of other auditor referred to in sub paragraph no. (a) of the "Other Matter" paragraph below, is sufficient and appropriate to provide a basis for our opinion on the standalone annual financial results.

These standalone annual financial results have been prepared on the basis of the standalone annual financial statements.

The Company's Management and the Board of Directors are responsible for the preparation and presentation of these standalone annual financial results that give a true and fair view of the net profit/ loss and other comprehensive income and other financial information in accordance with the recognition and measurement principles laid down in Indian Accounting Standards prescribed under Section 133 of the Act and other accounting principles generally accepted in India and in compliance with Regulation 33 of the Listing Regulations. The respective Management and Board of Directors of the Company/Board of Trsutees of the ESOP trust are responsible for maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company/ESOP trust and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and the design,

implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring accuracy and completeness of the accounting records, relevant to the preparation and presentation of the standalone annual financial results that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the standalone annual financial results, the respective Management and the Board of Directors/Board of Trsutees are responsible for assessing the Company's/ESOP trust's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the respective Board of Directors/Board of Trustees either intends to liquidate the the Company/ESOP trust or to cease operations, or has no realistic alternative but to do so.

The respective Board of Directors/Board of Trustees are responsible for overseeing the financial reporting process of the Company/ESOP trust.

Auditor's Responsibilities for the Audit of the Standalone Annual Financial Results

Our objectives are to obtain reasonable assurance about whether the standalone annual financial results as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these standalone annual financial results.

As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the standalone annual financial results, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances. Under Section 143(3) (i) of the Act, we are also responsible for expressing our opinion through a separate report on the complete set of financial statements on whether the company has adequate internal financial controls with reference to financial statements in place and the operating effectiveness of such controls.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures in the standalone annual financial results made by the Management and Board of Directors.
- Conclude on the appropriateness of the Management and Board of Directors use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the appropriateness of this assumption. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the standalone annual financial results or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Company to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the standalone annual financial results, including the disclosures, and whether the standalone annual financial results represent the underlying transactions and events in a manner that achieves fair presentation.
- Obtain sufficient appropriate audit evidence regarding the financial results of the ESOP trust of the Company to express an opinion on the standalone annual financial results. For the ESOP trust included in the standalone annual financial results, which has been audited by other auditor, such other auditor remain responsible for the direction, supervision and performance of the audit carried out by them. We remain solely responsible for our audit opinion. Our responsibilities in this regard are further described sub paragraph no. (a) of the "Other Matter" paragraph in this audit report.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

Other Matter(s)

- a. The standalone annual financial results include the audited financial results of an ESOP trust, whose financial statements reflect total assets (before consolidation adjustments) of Rs. 1,305.77 lakhs as at 31 March 2022, total revenue (before consolidation adjustments) of Rs. 315.45 lakhs and total net profit after tax (before consolidation adjustments) of Rs. 259.65 lakhs, and net cash outflows (before consolidation adjustments) of Rs. 29.02 lakhs for the year ended on that date, as considered in the standalone annual financial results, which has been audited by its other auditor. The other auditor's report on financial statements of this ESOP trust has been furnished to us by the management.
 - Our opinion on the standalone annual financial results, in so far as it relates to the amounts and disclosures included in respect of this ESOP trust, is based solely on the report of such auditor.
 - Our opinion is not modified in respect of this matter.
- b. The standalone annual financial results include the results for the quarter ended 31 March 2022 being the balancing figure between the audited figures in respect of the full financial year and the published unaudited year to date figures up to the third quarter of the current financial year which were subject to limited review by us.

- 2. The Company is a registered power exchange and the same constitutes a single operating segment.
- 3. Pursuant to approval given by its shareholders, the Company has during the year ended 31 March 2022, issued 599,113,022 bonus equity shares of Re. 1/- each as fully paid-up bonus equity shares in the ratio of 2 (Two) equity shares of Re. 1/- each for every 1 (One) existing equity share of Re. 1/- each. Accordingly, the earnings per share has been adjusted for previous periods and presented in accordance with Ind AS 33, Earnings Per Share.
- 4. The Company had framed an "Employee Stock Option Scheme 2010" ("ESOP Scheme"), which was duly approved by the Shareholders and Board of Directors of the Company. The ESOP Scheme is administered by IEX ESOP Trust ("ESOP Trust") on behalf of the Company. During the current year, 119,400 options (pre bonus) and 150,000 options (post bonus) out of the options granted earlier, have been exercised.
- 5. Figures for the quarter ended 31 March 2022 and 31 March 2021 are balancing figures between the audited figures in respect of the full financial year and the published year to date figures up to the end of the third quarter of the relevant financial year. Also, the figures up to the end of the third quarter were only reviewed and not subjected to audit.
- 6. The above audited standalone annual financial results were reviewed by the Audit Committee and approved by the Board of Directors in their respective meetings held on 27 April 2022. These have been audited by the Statutory Auditor of the Company.
- 7. In view of pandemic related to COVID 19, the Company has considered internal and external information and has performed its own analysis based on current estimates in assessing the recoverability of its investment, right of assets use and other financial assets, for possible impact on the Standalone Financial Statements. However, the actual impact of COVID·19 on the Company's standalone financial results may differ from that estimated and the Company will continue to closely monitor any material changes to future economic conditions.
- 8. The Indian Parliament has approved the Code on Social Security, 2020 which would impact the contributions by the Company towards Provident Fund and Gratuity. The effective date from which the changes are applicable is yet to be notified and the final rules are yet to be framed. The Company will carry out an evaluation of the impact and record the same in the financial results in the period in which the Code becomes effective and the related rules are published.



9. On 17 January 2022, the Company executed a transaction for sale of 4.93% stake in Indian Gas Exchange

Limited (IGX), to Indian Oil Corporation Limited (IOCL) consisting of 3,693,750 equity shares, having a

face value of Rs.10 each. This transaction has consequently resulted in cessation of Holding-Subsidiary

Relationship between Indian Energy Exchange Limited and Indian Gas Exchange Limited from that date

and the resultant gain which has accrued to Indian Energy Exchange Limited for loss of control has been

disclosed as an exceptional item in these financial results.

10. The ESOP trust has been treated as an extension of the Company and accordingly, shares held by ESOP

Trust ("the Trust") are netted off from the total share capital. Consequently, all the assets, liabilities,

income and expenses of the Trust are accounted for as assets, liabilities, income and expenses of the

Company, except for profit / loss on issue of shares to the employees and the dividend earned by the trust

which are directly taken to the ESOP Trust reserve.

11. On 24 January 2022, the Board of Directors had declared an interim dividend of Re. 1/- per share (on equity

share of par value of Re. 1 each) for FY 2021-22. This interim dividend has been paid to the equity

shareholders of the Company, whose names were appearing in the Register of Members of the Company

or in the records of the depositories as beneficial owners of the shares, on 4 February 2022, which was the

record date fixed for this purpose.

Pursuant to approval given by its shareholders, the Company has during the year ended 31 March 2022, issued 599,113,022 bonus equity shares of Re. 1/- each as fully paid-up bonus equity shares in the ratio of 2 (Two) equity shares of Re. 1/- each for every 1 (One) existing equity share of Re.1/- each. Accordingly, the earnings per share has been adjusted for previous periods and presented in accordance with Ind AS 33, Earnings Per Share.
- 4. The Company had framed an "Employee Stock Option Scheme 2010" ("ESOP Scheme"), which was duly approved by the Shareholders and Board of Directors of the Company. The ESOP Scheme is administered by IEX ESOP Trust ("ESOP Trust") on behalf of the Company. During the current year, 119,400 options (pre bonus) and 150,000 options (post bonus) out of the options granted earlier, have been exercised.
- 5. Figures for the quarter ended 31 March 2022 and 31 March 2021 are balancing figures between the audited figures in respect of the full financial year and the published year to date figures up to the end of the third quarter of the relevant financial year. Also, the figures up to the end of the third quarter were only reviewed and not subjected to audit.
- 6. The above audited consolidated annual financial results were reviewed by the Audit Committee and approved by the Board of Directors in their respective meetings held on 27 April 2022. These have been audited by the Statutory Auditor of the Company.
- 7. In view of pandemic related to COVID 19, the Company has considered internal and external information and has performed its own analysis based on current estimates in assessing the recoverability of its investment, right of assets use and other financial assets, for possible impact on the Standalone Financial Statements. However, the actual impact of COVID·19 on the these financial statements may differ from that estimated and the Company will continue to closely monitor any material changes to future economic conditions.
- 8. The Indian Parliament has approved the Code on Social Security, 2020 which would impact contributions by the Company towards Provident Fund and Gratuity. The effective date from which the changes are applicable is yet to be notified and the final rules are yet to be framed. The Company will carry out an evaluation of the impact and record the same in the financial results in the period in which the Code becomes effective and the related rules are published.



9. On 17 January 2022, the Company executed a transaction for sale of 4.93% stake in Indian Gas Exchange Limited (IGX), to Indian Oil Corporation Limited (IOCL) consisting of 36,93,750 equity shares, having a

face value of Rs. 10 each. This transaction has consequently resulted in cessation of Holding-Subsidiary

Relationship between Indian Energy Exchange Limited and Indian Gas Exchange Limited from that date

and the resultant gain which has accrued to Indian Energy Exchange Limited on loss of control has been

disclosed as an exceptional item in these financial results.

10. The ESOP trust has been treated as an extension of the Company, and accordingly, shares held by ESOP

Trust ("the Trust") are netted off from the total share capital. Consequently, all the assets, liabilities,

income and expenses of the Trust are accounted for as assets, liabilities, income and expenses of the

Company, except for profit / loss on issue of shares to the employees and the dividend earned by the trust

which are directly taken to the ESOP Trust reserve.

11. On 24 January 2022, the Board of Directors of Company had declared an interim dividend of Rs. 1/- per

share (on equity share of par value of Re. 1 each) for FY 2021-22. This interim dividend has been paid to

the equity shareholders of the Company, whose names were appearing in the Register of Members of the

Company or in the records of the depositories as beneficial owners of the shares, on 4 February 2022,

which was the record date fixed for this purpose.

Further, the Board of Directors of the Company have recommended a final dividend of Re. 1/- per equity

share of face value Re. 1 each for the financial year ended 31 March 2022, subject to the approval of the

Shareholders of the Company at the ensuing Annual General Meeting.

12. The audit report of the Statutory Auditor is being filed with BSE Limited and National Stock Exchange of
