We did not review the interim financial results of a subsidiary included in the statement whose financial results reflect total assets of Rs 4170.14 Lakhs as at June 30, 2023, and total revenues of Rs 2.48 Lakhs, total net profits after tax of Rs 1.64 Lakhs and total comprehensive income of Rs. (369.47) Lakhs for the Quarter ended June 30, 2023, as considered in the consolidated unaudited financial results. The consolidated financial results also include the group share in net profit of Rs (194.69) Lakhs and total comprehensive income of Rs 682.06 Lakhs for the quarter ended June 30, 2023, as considered in consolidated financial results, in respect of one associate, whose financial results have not been reviewed by us. This financial results/ financial information has been reviewed by other auditors whose reports have been furnished to us by the Management and our conclusion on the consolidated financial statements, in so far as it relates to the amounts and disclosures included in respect of the subsidiary and associate is based solely on the report of other auditors and procedure performed by us as stated in paragraph 3 above.
