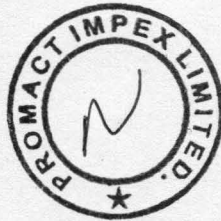

LIMITED REVIEW REPORT

Review report to the Board of Directors of Promact Impex Limited (formerly known as Promact Plastics Limited)

We have reviewed the accompanying statement of unaudited standalone financial results of **Promact Impex Limited (formerly known as Promact Plastics Limited)** (CIN : L25200GJ1985PLC007746) for the period ended **30th June 2021** ("the statement"), being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements), 2015, as amended ("the Listing Regulations").
