still pending judgement. Hence the company has classified these loans as bad debts. The statements also includes a one time expense of Rs.36.7 lacs that the company paid for settlement of disputes against the Income Tax department in the Vivaad se Vishwas Scheme

Our responsibility is to express an opinion on these standalone annual financial results based on our audit of the annual financial statements which have been prepared in accordance with the recognition and measurement principles laid down in the Companies (Indian Accounting Standards) Rules, 2015 as per Section 133 of the Companies Act, 2013 and other accounting principles generally accepted in India and in compliance with Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.
