

NOTES:-

- 1 The above financial results were reviewed by the Audit Committee and thereafter approved by Board of Directors at their respective meetings held on 29th May, 2023.
- 2 Financial results for all the periods presented have been prepared in accordance with the recognition and measurement principles of Ind As notified under the Companies (Indian Accounting Standards) Rules, 2015 as amended from time to time.
- 3 The Company operates in single business segment of Paper and there are no separate reportable segments.
- 4 Previous period/Year figures have been regrouped / rearranged , wherever deemed necessary.
- 5 The figures for the quarter ended March 31, 2023 and March 31, 2022 are balancing figures between audited figures in respect of the full financial year and the published year to date figures up to third quarter of the relevant financial year which were subjected to limited review.
- 6 The Board of Directors of the Company has recommended a dividend of Rs. 5/- per equity share of face value of Rs. 10/- each for the F.Y 2022-23, which is subject to approval of the shareholders at the ensuing Annual General Meeting.
- 7 The Allotment Committee/Board of the Company, at its meetings held on 20th June 2022 and 13th August 2022, has successfully converted a total of 9,52,500 and 9,75,000 Shares warrants into Equity Shares. These warrants were preferentially allotted to the promoter group in the financial year 2020-21 at a premium of Rs. 52/- per share. The conversion of these warrants into equity shares has been carried out in accordance with all applicable legal provisions and within the stipulated time frame. The Company has diligently complied with the necessary requirements and procedures as mandated by the law.
- 8 The Board of Directors of the Company at its meeting held on 14th October 2022 has made allotment of 2713181 Bonus Equity Shares of the face value of Rs. 10/- each. Consequently, upon the allotment of these Bonus equity shares, the paid-up equity capital of the Company now stands at Rs. 29,84,49,850/-, comprising 2,98,44,985 equity shares of the face value of Rs. 10/- each.
