

- 2 The above Standalone and Consolidated Financial Results have been prepared in accordance with the guidelines issued by the Securities and Exchange Board of India ("SEBI") and the Indian Accounting Standards (Ind AS) prescribed under Section 133 of the Companies Act, 2013.
- 3 The Company has not elected to exercise its option permitted U/S 115BAA of the Income tax act, 1961 and provision of current tax has been made as per the normal provisions of the Income Tax Act,1961 and rules frame there under. Further current tax for the year ended 31st March 2023 has been provided based on normal provisions after utilising available MAT (Minimum Alternate Tax) credit amounting to Rs. 40.79 laacs under Income Tax Act,1961.
- 4 Other income includes net gain arising on sale of investment Rs. 86.44 Lacs and Rs. 239.48 Lacs for the year ended on 31st March 2023 and 31st March 2022 respectively and net gain arising on investments measured at FVTPL amounting Rs.NIL and Rs.34.03 Lacs for the year ended on 31st March 2023 and 31st March 2022 respectively. Further, Other expenses includes loss arising on investment measured at FVTPL Rs.131.32 Lacs and Rs. NIL for the year ended on 31st March 2023 and 31st March 2022 respectively.
