INDEPENDENT AUDITOR'S REVIEW REPORT ON REVIEW OF INTERIM STANDALONE FINANCIAL RESULTS

- 1. We have reviewed the accompanying statement of unaudited standalone financial results of M/s. Sugal & Damani Share Brokers Limited ("The Company"), for the quarter and nine month ended 31st December, 2022 ("this statement"), being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and disclosure Requirements) Regulations, 2015 as amended.
- 2.
