

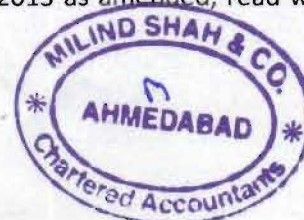
Review Report

1. We have reviewed the accompanying Statement of Unaudited Standalone Financial Results of **Unjha Formulations Limited** ("the Company") for the quarter ended June 30, 2023 ("the Statement") attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, as amended (the "Listing Regulations").

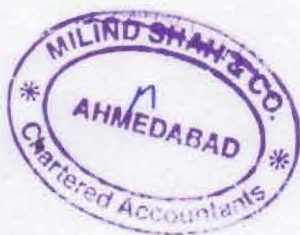
