- We did not review the interim financial information of twosubsidiaries(VLS Securities Limited and VLS Asset Management Limited) included in the consolidated unaudited financial statement, whose interim financial information reflect total revenues of Rs.519.17lakh, total net profit after tax of Rs.398.33lakhand total comprehensive income of Rs.33,997.35 lakhfor the quarter ended 30th June, 2021, The Statement also includes the Group's share of net profit after tax Rs 6.64 lakh and total comprehensive income of Rs 9.28 lakhs for the quarter ended 30th June, 2021, in respect of VLS Capital Limited (associate company). These financial information have been reviewed by other auditors whose review report has been furnished to us by the management and our conclusion on the statement, in so far as it relates to the amounts and disclosures included in respect of this subsidiariesis based solely on the review report of such other auditors and the procedures performed by us as stated in paragraph 3 above.
- The consolidated unaudited financial results includes the interim financial information of VLS Real Estate Limited(subsidiary company), whose financial statements / financial results reflecttotal revenue of Rs. Nil, total net profit/(loss) after tax of Rs.Nil lakh and total comprehensive income/(loss) of Nil lakh for the quarter ended 30th June, 2021, based on their financial information, which have not been reviewed by their auditor, and have been furnished to us by the management of VLS Finance Limited. Our conclusion on their statement, in so far as it relates to the aforesaid subsidiary, is solely based on such management certified un-reviewed financial information. According to the information and explanations given to us by the Management, these interim financial results are not material to the Group.



- 1. The standalone and consolidated unaudited financial results have been reviewed by the Audit Committee and taken on record by the Board of Directors of VLS Finance Limited (The "Company") in its meeting held on 26th July, 2021.
- 2. The limited review for the quarter ended and for the period ended 30th June, 2021, as required under Regulation 33 of SEBI (Listing Obligation & Disclosure Requirements) Regulation, 2015 has been carried out by the Statutory Auditors.
- 3. The Company has taken into account the possible impact of known events arising out of COVID 19 pandemic in the preparation of financial results. The Company will continue to monitor for any material changes to future economic conditions.
- 4. These Financial Results have been prepared in accordance with Division III of Schedule III, the format for financial statements of Non-Banking Financial Companies, as defined in the Companies (Indian Accounting Standards) (Amendments) Rules 2016 read with section 133 of the Companies Act, 2013.
- 5. The consolidated accounts have been prepared as per IND AS 110 on Consolidated Financial Statements and IND AS 28. The consolidated results as shown include the unaudited results of the subsidiaries viz. VLS Securities Limited, VLS Asset Management Limited and VLS Real Estate Limited for the quarter ended 30th June 2021. Further, as regards the results of the associate as defined under the Companies Act 2013, the Company's share of net profit in respect of VLS Capital Limited is also considered.
- 6. The Taxation Laws (Amendment) Ordinance, 2019 contained substantial amendments in the Income Tax Act 1961 and the Finance (No.2) Act, 2019 had provided an option to domestic companies to pay income tax at a concessional rate. The Company had elected to apply the concessional tax rate. Accordingly, the Company has recognized the provision for income tax and re-measured the net deferred tax liabilities at concessional rate from the financial year 2019-20. Further, the subsidiary company VLS Securities Limited has also elected to exercise the option permitted under section 115BAA of the Income Tax Act, 1961 from the financial year i.e. 2020-21. Accordingly, the subsidiary company has also recognized provision for Income Tax and re-measured its Deferred tax liabilities on the basis of the rate prescribed in the aforesaid section and recognized the
