Independent Auditor's Review Report of the Third Quarter Ended of Julien Agro Infratech Limited formerly known as (Silverpoint Infratech Limited) pursuant to the Regulation 33 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015, (as amended)

To the Board of Directors of Julien Agro Infratech Limited formerly known as Silverpoint Infratech Limited

1. We have reviewed the accompanying Statement of Un-audited Financial Result ('Statement') of **Julien Agro Infratech Limited** (*the Company*) for the third quarter ended December 31, 2023, which are included in the accompanying "Statement of Un-audited Financial Results for the third quarter ended December 31, 2023" together with the notes thereon (the "Statement").
