We have reviewed the accompanying Statement of Unaudited Consolidated Financial Results of Genus Prime Infra Limited (the "Parent") and its three wholly owned subsidiary (the Parent and its subsidiary, together referred to as "the Group") for the quarter ended December 31, 2022 and year to date from April 01, 2022 to December 31, 2022 (the "Statement") attached herewith, being submitted by the Parent pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations").
2. This Statement, which is the responsibility of the Parent's Management and approved by the Parent's Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34, (Ind AS 34) "Interim Financial Reporting" prescribed under Section 133 of the Companies Act, 2013 as amended, read with relevant rules issued thereunder and other accounting principles generally accepted in India. Our responsibility is to express a conclusion on the Statement based on our review.
3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review of interim financial information consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. Pending final approval from appropriate authorities, no impact/disclosure has been given in respect of the above transactions in the books of the Company for the quarter and nine months ended December 31, 2022.
7. The accompanying Statement includes unaudited interim financial results and other unaudited financial information, in respect of:
 - Three wholly owned subsidiary, whose unaudited interim financial results reflect total Income of Rs. 0.60 Lacs and Rs. 2.41 Lacs, total net profit after tax of Rs. 0.04 Lacs and Rs (0.05) Lakhs, and Other comprehensive income of Rs. Nil for the quarter and Nine Months ended on December 31, 2022 respectively, as considered in the Statement, which have been reviewed by its independent auditor.
