## INDEPENDENT AUDITOR'S REVIEW REPORT ON REVIEW OF INTERIM STANDALONE **FINANCIAL RESULTS**

### TO THE BOARD OF DIRECTORS OF **GLOBUS SPIRITS LIMITED**

1. We have reviewed the accompanying Statement of Standalone Unaudited Financial Results of GLOBUS SPIRITS LIMITED ("the Company"), for the quarter ended June 30, 2018 ("the Statement"), being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as modified by Circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016.

This Statement which is the responsibility of the Company's Management and approved by the Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in the Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder and other accounting principles generally accepted in India. Our responsibility is to issue a report on the Statement based on our review.

- 2. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 'Review of Interim Financial Information Performed by the Independent Auditor of the Entity', issued by the Institute of Chartered Accountants of India. This Standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review is limited primarily to inquiries of Company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and, accordingly, we do not express an audit opinion.
- 3. Based on our review conducted as stated above, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with the aforesaid Indian Accounting Standards and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as modified by Circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016, including the manner in which it is to be disclosed, or that it contains any material misstatement.
- 4. We draw attention to Note 3 of the Statement which describes the status of operations upon grant of permission for manufacture and sale of Extra Neutral Alcohol (ENA) under the Bihar Prohibition and Excise Act, 2016, in respect of one of the manufacturing plant located in Bihar.

### Notes to Standalone Financial Results for the Quarter ended June 30, 2018

#### Notes:

- 1 The above Standalone Financial Results were reviewed by the Audit Committee and approved at the meeting of the Board of Directors of the Company at its meeting held on August 10, 2018.
- 2 As the Company's business actively falls within a single primary business segment, namely Alcohol and Alcoholic Beverages, the disclosure requirements of Regulation 33 of the SEBI (Listing Obligations and disclosure Requirements) Regulations, 2015 in terms of Ind AS 108 Operating Segments are not applicable.
- 3 In light of the permission granted to the Company by The Prohibition, Excise & Registration Department, Government of Bihar, Patna on May 04, 2018, The Company is in the process of recommencing its operations at the manufacturing plant located in Bihar, and expects to recommence the operations during financial year 2018-2019. The operations were discontinued w.e.f financial year 2017-18 due to prohibition on manufacture of Extra Neutral Alcohol (ENA) in Bihar. Assets at the Bihar manufacturing plant have a net book value of Rs. 12,048.93 lacs (as on March 31, 2018 Rs. 12,187.54 lacs). In the view of the management no provision is considered necessary to the carrying cost of these assets as at June 30, 2018
- 4 Tax expense Deferred tax is net of MAT credit of Rs. 264.32 lacs relating to current quarter.
- 5 The Company has aligned its policy of Revenue Recognition with Ind AS 115 "Revenue from Contracts with Customers" which is effective from April 01, 2018. Accordingly, the Company has excluded the below mentioned amounts in its Statement of Profit and Loss with respect to its arrangements with Brand franchisee. Consequent to these changes, there is no impact on the total equity and profit.
