To, The Board of Directors Gowra Leasing & Finance Limited.

- 1. We have reviewed the accompanying statement of unaudited financial results of **GOWRA LEASING & FINANCE LIMITED** ("the Company") for the Quarter and half year ended 30th September, 2023 ("the Statement") attached herewith being submitted by the Company pursuant to the requirements of Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements, 2015 as amended ('the Listing Regulations').
- 2.
