#### **INDEPENDENT AUDITOR'S REPORT**

#### TO THE BOARD OF DIRECTORS OF GOYAL ASSOCIATES LIMITED

#### Report on the audit of the Standalone Financial Results

#### Opinion

We have audited the accompanying standalone quarterly financial results of Goyal Associates Limited for the quarter ended 31<sup>st</sup> March,2022 and the year to date results for the period from 01.04.2021 to 31.03.2022, attached herewith, being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations").

In our opinion and to the best of our information and according to the explanations given to us these standalone financial results:

- i. are presented in accordance with the requirements of Regulation 33 of the Listing Regulations in this regard; and
- ii. give a true and fair view in conformity with the recognition and measurement principles laid down in the applicable accounting standards and other accounting principles generally accepted in India of the net profit/loss<sub>3</sub> and other comprehensive income and other financial information for the quarter ended 31<sup>st</sup> March,2022 as well as the year to date results for the period from 01.04.2021 to 31.03.2022.

### **Basis for Opinion**

We conducted our audit in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Companies Act, 2013 (the Act).
