- 5) The operations of the company were impacted due to shutdown of offices following lockdown imposed but he Government Authorities to contain spread of Covid-19 pandemic. The company has resumed operations in phased manner as per the directives from the government authorities.

Cue to the Covid-19 pandemic there has been impact on export revenue which has been to a certain extent offset by reduction in expenditure. With the easing of lockdown, traffic and monetization are improving and the impact of any revised lockdown/restrictions in certain geographies is being monitored.
