Report on audit of the Standalone Financial Results

Opinion

We have audited the accompanying standalone annual financial results of Saptak Chem and Business Limited (the company) for the year ended 31st March, 2021, attached herewith, being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations").

In our opinion and to the best of our information and according to the explanations given to us these standalone financial results:
