However, in accordance with the terms of the agreements with jointventure partners, the Company's substantive rights would remain restricted.. Therefore, the Company shall continue to consolidate the investment in HHFGPL in accordance with the Ind AS 28 - Investment in Associates and Joint ventures.

- 6. The Company has only one Operating Segment as per IND-AS 108 "Operating Segment", Accordingly disclosures as per SEBI Circular No. CIR/CFD/FAC/62/2016 dated 05th July 2016 is not required.
- 7. Figures for the previous period been regrouped / reclassified to conform to those for the current period.
