- These financial results have been prepared in accordance with the recognition and measurement principles of applicable Indian Accounting Standards ('Ind. AS') notified under the Companies (Indian Accounting Standards) Rules, 2015, (as amended) as specified in Section 133 of the Companies Act, 2013.
- 2 The company is a single segment company. Therefore the provisions of Ind AS 108 'Operating Segments' are not applicable to the Company.
- The Central Government has announced a new scheme called Remission of Duties or Taxes on Export Product (RODTEP) which has replaced Merchandise Export from India Scheme (MEIS) benefit w.e.f. 01st January, 2021. As the rates under RoDTEP have not been declared till date, the income on account of benefits under the new scheme has not been recognized for the quarter/ year ended 31st March 2021 on account of uncertainty.
- 4 24,39,000, 5% Non-Convertible Non-Cumulative Redeemable Preference Shares having face value of Rs. 10/- each (issued during FY 2000-01 at premium of Rs. 25/- per Share) have been redeemed at a premium of Rs. 90/- per share during the quarter ended 31st March 2021. The difference between the carrying amount of the liability component of the said redeemed Preference Shares and consideration paid has been recognised as exceptional item in the Statement of Profit and Loss. The said Preference Shares having been redeemed out of the proceeds of fresh issue of 5% Non-Convertible Non-Cumulative Redeemable Preference Shares having face value of Rs. 10/- each at a premium of Rs. 90/- per share does not have any impact on overall other equity and cash flows of the company.
- The company has elected to exercise the option permitted under Section 115BAA of the Income tax Act, 1961 during the current year. Accordingly, the Company has recognized income tax expense and re-measured its deferred tax liability on the basis of rate prescribed in the said section. Therefore, the income tax expense for the current periods is not comparable with income tax expense of corresponding periods of previous year.
- The Company has made assessment of impact of COVID-19 on the carrying amount of property, plant and equipment, inventories, receivables and other current assets. Based on current indicators of future economic conditions, the Company expects to recover the carrying amount of the assets. However in view of highly uncertain and continously evolving business environment, the eventual impact of COVID-19 may be different from the estimated as at the date of approval of these financial results. The company will continue to moniter any material changes arising out of futher economic conditions and its impact on business.
- 7 The Code on Social Security, 2020 ('Code') relating to employee benefits during employment and post-employment benefits has been notified in the Official Gazette on 29th September 2020. The draft rules have been released on November 13, 2020 and suggestions have been invited from stakeholders which are under consideration by the Ministry. The impact of the change will be assessed and accounted in the period in which said rules are notified for implementation.
- B The figures of the quarter ended 31st March, 2021 and 31st March, 2020 are the balancing figures between the audited figures in respect to the said full financial year and the published unaudited figures upto nine months ended 31st December, 2020 and 31st, December, 2019 respectively, which have been subject to limited review by the Statutory Auditors.
- The figures of the corresponding previous period / year have been regrouped wherever considered necessary to correspond to current period / year disclosures.
- 10 The above Audited financial results for the quarter/ year ended 31st March 2021 were reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on 24th April 2021. The Statutary auditors had expressed an unmodified opinion on the aforesaid results.
