Emphasis of Matter

- The Board of Directors has declared interim dividend of Rs. 1.2 per equity share (face value of Rs. 10 per equity share) in its board meeting held on March 14, 2020.
- Tax Expenses for the quarter and year ended 31st March 2020 reflect changes made vide Taxation Laws Amendment Ordinance 2019 as applicable to the company.

- The Company has adopted Ind AS 116 with modified retrospective approach, with effect from April 1, 2019. Accordingly, the comparative periods have not been restated. There is no impact of Ind AS 116 adoption to the retained earnings as at April 1, 2019. The Company has recognized ₹1.90 crores as right of use assets and the corresponding lease liability on the date of transition i.e. April 1, 2019. In the financial statements for the year ended March 31, 2020, the nature of expenses in respect of operating leases has changed from lease rent in previous period to amortisation for the right of use asset and finance cost for interest accrued on lease liability. There is no material impact on loss after tax and earnings per share for the year ended March 31, 2020, on adoption of Ind AS 116
- Covid-19 pandemic has been rapidly spreading throughout the world, including India. Government in India has taken significant measures to curb the spread of the virus including imposing mandatory lockdowns and restrictions in activities. Consequently, Company's manufacturing plants and offices had to be closed down for a considerable period of time, including after the yearend. As a result of the lockdown, the likely revenue from the month of March 2020 has been impacted. Continued lockdowns are likely to impact the Company operationally including on supply chain matters. The Company is monitoring the situation closely taking into account directives from the Governments. Management believes that it has taken into account all the possible impacts of known events arising from COVID-19 pandemic and the resultant lockdowns in the preparation of the financial statements including but not limited to its assessment of Group's liquidity and going concern, recoverable values of its property, plant and equipment, intangible assets, and the net realisable values of other assets. However, given the effect of these lockdowns on the overall economic activity and in particular on the textile & garment industry, the impact assessment of COVID-19 on the abovementioned financial statement captions is subject to significant estimation uncertainties given its nature and duration and, accordingly, the actual impacts in future may be different from those estimated as at the date of approval of these financial statements. The Company will continue to monitor any material changes to future economic conditions and consequential impact on its financial results.

- 10 Figures for the previous period have been regrouped wherever necessary.
- The figures for quarter ended 31st March 2020 and 31st March 2019 are balancing figures between the audited figures in 11 respect of the financial year upto 31st March 2020 and 31st March 2019 and unaudited published nine months figures upto 31st December 2019 and 31st December 2018, being the date of the end of the third quarter of the financial year, which were subject to limited review.
- The financial statements of the Company for the year ended 31 March 2020 have been prepared in accordance with the Indian Accounting Standards (Ind-AS) as prescribed under Section 133 of the Companies Act, 2013. The statutory auditors have issued unmodified opinion on these financial statements.
