These financial results for the quarter ended 30 <sup>th</sup> June, 2023 have also been reviewed by the Statutory Auditors of the Company in compliance with the requirements of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
2	The company does not have separate reportable segments in terms of Indian Accounting Standard (Ind AS-108) on "Operating Segments".
3	The company has made provision on loans (impairment) as per Expected credit Loss (ECL) method amounting to ₹ 2407.67 crore as on 30 <sup>th</sup> June, 2023 (₹ 2503.34 crore as on 30 <sup>th</sup> June, 2022) as per Ind-AS requirement.
4	In respect of Andrews Ganj Project (AGP) being executed by HUDCO as an agent on behalf of MoUD (now MoHUA), HUDCO does not have any right or interest in the property leased to it. Expenditure and liability, if any, on account of this project is paid out of "No Lien AGP Account" maintained with HUDCO. The company continues to book the interest income & expenditure incurred as per past practice. Interest income of ₹ 7.19 crore on the amount of deficit (recoverable) from MoHUA has been booked for the quarter ended $30^{th}$ June, 2023.
