- The Company is engaged in the business of manufacturing and trading of modular furniture and furniture fabric. Hence no 6] separate segment reporting required. Compared with last year, there was slow in business and delay in obtain order, company has not performed well. However, Management is confident to have better business and complite ongoing order.
