- 5. The Company has raised an amount of Rs.2,948.19 lakhs through the Rights issue of 5,89,63,835 Equity Shares of Rs.5/· each at an issue price of Rs.5/· per Share. The Shares have been allotted to the Shareholders on March 15,2023. Consequent to the above allotment, the paid up Share Capital has increased from Rs.4,508.99 lakhs to
