To consider and if thought fit, to pass with or without modification(s), the following resolution by way of special majority (i.e. where the votes cast in favour of the resolution are required to be not less than one and a half times the votes cast against the resolution) by the unitholders in terms of the provisions of Regulation 22(5)(a) of the Securities and Exchange Board of India (Infrastructure Investment Trusts) Regulations, 2014, as amended from time to time:

To consider and if thought fit, to pass with or without modification(s), the following resolution by way of special majority (i.e. where the votes cast in favour of the resolution are required to be not less than one and a half times the votes cast against the resolution) by the unitholders in terms of the provisions of Regulation 22(5)(d) of the Securities and Exchange Board of India (Infrastructure Investment Trusts) Regulations, 2014, as amended from time to time:

“Resolved that pursuant to Regulations 4(2)(h), 10, 22 and any other applicable provisions of the Securities and Exchange Board of India (Infrastructure Investment Trusts) Regulations, 2014 (as amended from time to time) (**“InvIT Regulations”**), including any applicable circulars, guidelines, notifications and clarifications issued thereunder, as well as the circular issued by the Securities and Exchange Board of India dated September 11, 2023 (bearing number SEBI/HO/DDHS-PoD-2/P/CIR/2023/153) (**“UHD Circular”**), the consent of the unitholders be and is hereby accorded for an amendment to the Indenture of Trust dated January 31, 2019, executed between Reliance Industrial Investments and Holdings Limited (as the settlor and one of the sponsors) and Axis Trustee Services Limited (as the trustee) (**“Trustee”**) (as amended by the amendment agreement dated August 30, 2021 and together with the deed of accession to the Indenture of Trust dated August 26, 2020 entered into among BIF IV Jarvis India Pte. The terms and conditions for the nomination and appointment of such director, as well as the vacation of office by such director, shall be as set out in (i) policies formulated in this regard, by the Trust and / or the Investment Manager; and (ii) the InvIT Regulations.”

Securities and Exchange Board of India ("SEBI") vide circular dated January 12, 2023, has permitted to hold general meetings, including this Extra-Ordinary General Meeting ("EGM/Meeting") of unitholders of infrastructure investment trusts through Video Conferencing ("VC") / Other Audio-Visual Mode ("OAVM"). In compliance with the provisions of the Securities and Exchange Board of India (Infrastructure Investment Trusts) Regulations, 2014 ("InvIT Regulations") and SEBI Circular, the EGM of the unitholders of Data Infrastructure Trust (formerly known as Tower Infrastructure Trust) ("Data InvIT/Trust") is proposed to be held on Monday, October 23, 2023, at 11.00 a.m. through VC to transact the aforesaid businesses. The notice is being issued to unitholders in compliance with Regulation 22(2)(c) of the SEBI InvIT Regulations. The deemed venue for the EGM shall be the principal place of business of the Trust.

EXPLANATORY STATEMENT

The following statements set out the material facts and reasons for the proposed resolutions stated in the accompanying notice above:

Item No. 1 - To consider and approve change in investment manager of Data Infrastructure Trust

Brookfield India Infrastructure Manager Private Limited (“**BIIMPL**”) was appointed as the investment manager of Data Infrastructure Trust (*formerly known as Tower Infrastructure Trust*) (“**InvIT**”) w.e.f. October 13, 2020 in terms of the provisions of Securities and Exchange Board of India (Infrastructure Investment Trusts) Regulations, 2014 (as amended from time to time) (“**InvIT Regulations**”) and pursuant to the Investment Management Agreement dated September 25, 2020 (“**IMA**”) executed between the Axis Trustee Services Limited, in the capacity of Trustee to the InvIT (“**Trustee**”) and BIIMPL, to manage the assets and investments of the InvIT and to undertake activities of the InvIT as specified under Regulation 10 of the InvIT Regulations.

BIIMPL has tendered its resignation from the role of the Investment Manager of the InvIT with effect from September 29, 2023. Therefore, it is now proposed that BIP India Infra Projects Management Services Private Limited (“**BIP**”) bearing Corporate Identification Number: U74999MH2017FTC303003, be appointed as the investment manager of the InvIT, in place of BIIMPL. BIP is an entity that is wholly owned and controlled (directly and indirectly) by the Brookfield group.

As stipulated under Regulation 9(15) of the InvIT Regulations, the Trustee is required to obtain the prior approval of the unitholders of the InvIT & from the Securities and Exchange Board of India (“**SEBI**”) for change in the investment manager of the Trust and to do all such acts, deeds and things as may be necessary in terms of the provisions of InvIT Regulations. To this effect, it is proposed that a new investment management agreement be executed with BIP (“**New IMA**”), for the purpose of appointment of BIP as the investment manager to the InvIT. The New IMA will be in form similar to the investment management agreement executed with BIIMPL, save and except for (i) modifications necessary for the purpose of complying with the provisions of the InvIT Regulations and the circulars issued thereunder and more specifically, the circular issued by the SEBI dated September 11, 2023 and bearing number SEBI/HO/DDHS-PoD-2/P/CIR/2023/153 to permit eligible unitholders to nominate such number of directors on the board of directors of the investment manager, in the manner and to the extent specified under the InvIT Regulations; and (ii) certain modifications that were required to clarify that BIP would be permitted to seek reimbursement of costs (in relation to its activities pertaining to the Trust) from the Trust or the Holdcos / SPVs, on whose behalf such costs have been incurred (which modification is being made only to cure ambiguities, and which would not in any manner prejudice the interests of the unitholders). BIIMPL will cease to be the investment manager of the InvIT with effect from the date of appointment of BIP as the new Investment Manager upon receipt of all required approvals and meeting with all eligibility criteria required under the InvIT Regulations.

BIF IV Jarvis India Pte. Ltd. (an affiliate of Brookfield), one of the sponsors of the Trust, being a related party to this proposal is considered interested in the resolution and will accordingly not be eligible to vote on resolution as set out in Item no. 1.

Accordingly, the Trustee recommends this resolution set out in item no. 1 of this notice for the approval of the unitholders.

Item No. 2 - To consider and approve an amendment to the Trust Deed of Data Infrastructure Trust

Attention of the unitholders is drawn to the Indenture of Trust dated January 31, 2019, executed between Reliance Industrial Investments and Holdings Limited (*as the settlor and one of the sponsors*) and Axis Trustee Services Limited (*as the trustee*) ("**Trustee**") (as amended by the amendment agreement dated January 31, 2019, together with the deed of accession to the trust deed dated August 26, 2020 entered into among BIF IV Jarvis India Pte. Ltd, Reliance Industrial Investments and Holdings Limited and the Trustee to include BIF IV Jarvis India Pte. Ltd. as a Sponsor to Data Infrastructure Trust (*formerly known as Tower Infrastructure Trust*) ("**InvIT**"), in respect of establishment and functioning of the InvIT (the "**Trust Deed**"). The Trust Deed is proposed to be amended to (i) comply with the provisions of the InvIT Regulations and the circulars issued thereunder, more specifically the circular issued by the SEBI dated September 11, 2023 and bearing number SEBI/HO/DDHS-PoD-2/P/CIR/2023/153 to permit eligible unitholders to nominate such number of directors on the board of directors of the investment manager, in the manner and to the extent specified under the InvIT Regulations; and (ii) amend the principal place of business of the Trust pursuant to the unitholders' approval received on December 16, 2022 in this regard.

The amendments proposed to be made to the Trust Deed are as follows:
