In developing the assumptions relating to the possible future uncertainties in the global economic conditions because of this pandemic, the Company has, at the date of approval of these financial statements, used internal and external sources of information including credit reports and related information and economic forecasts and expects that the earrying amount of these assets will be recovered. The impact of Covid-19 on the Company's financial statements may differ from that estimated as at the date of approval of these standalone financial statements.

e) The entire operations of the Company relate to only one segment viz., laying of gas pipe lines and development of allied infrastructure. Hence segmental reporting as per Ind AS 108 is not made.

During the quarter, CPM Likhitha consortium, a partership firm, which is a joint venture of the Company has commenced its operations. Hence, consolidated financial results have been prepared in terms of IND AS 110.

g) The EPS for the year ended 31.03.2021 was calculated based on the weighted average number of shares outstanding as on 31.03.2021

h) Figures for the quarter ended 31.03.2022 was the balancing figures for the year ended 31.03.2022 out of audited financial results for the year ended March 31, 2022.
