**Report on the audit of the Standalone Financial Results**

### **Opinion**

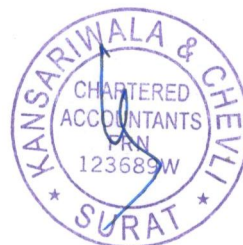

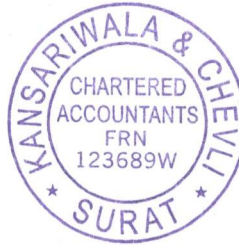
