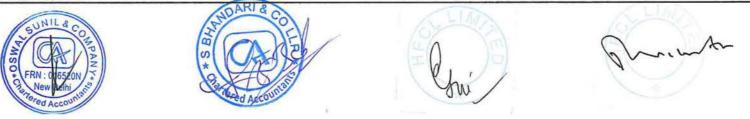

On standalone basis, the Company reported a quarterly Revenue of ₹ 1323 Cr, EBIDTA of ₹ 114 Cr, PBT of ₹ 69 Cr, and PAT of ₹ 51 Cr.
