Opinion

Qualifications:

- 1. Note (4) The finished goods and work-in progress have been valued at estimated cost. The estimated Cost has been arrived by deducting certain percentage towards margin from the estimated selling price. We are unable to obtain sufficient and appropriate audit evidence about approximation of the estimated cost to the Actual cost as required by the lnd AS 2 "Inventories" from the records maintained by the company. Consequently, we are unable to determine the impact of the same on the financial statements for the year end 31st March 2022.
- 2. Balance confirmations have not been received from Trade receivables, Other Financial assets and Other Financial liabilities against balance outstanding as on 31st March 2022. In the absence of such confirmations, we are unable to comment on the impact arising out of reconciliation/adjustments, if any, on the financial statements for the year end 31st March 2022.
