- We have reviewed the accompanying statement of Standalone Unaudited Financial Results of IYKOT HITECH TOOLROOM LIMITED (the 'Company') for the quarter ended 30<sup>th</sup> June, 2021 (the Statement) attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('the Regulations'), read with SEBI Circular No. CIR/CFD/CMD1/44/2019 dated March 29, 2019 ('the Circular').
