- 1 The above results have been reviewed by Statutory Auditors, recommended by Audit Committee and approved by the Board of Directors of the Company, in their meeting held on 9th February, 2021.
- 2 The Company has only one segment of activity, namely "Hoteliering".
- 3 The Company has considered internal and external sources of information, economic forecast and industry report up to date of approval of the financial results in determining impact of COVID-19 pandemic on various elements of its business operations and financial statements. The eventual outcome of impact of global health pandemic may be different from those estimated as on the date of approval of these financial results, depending on how long the pandemic lasts and time period taken for the economic activities to return to normalcy.

The Company faces significant economic uncertaintities due to COVID-19 which have impacted the operations of the Company adversely starting from the month of March 2020 onwards particularly by way of reduction in occupancy of hotels and average realization rate per room. In the month April, 2020 to Oct, 2020, the hotels have been operational at a significantly reduced occupancy rate. Management is undertaking various cost saving initiatives to maximise operating cash flows in the given situation. Management has assessed the impact of existing and anticipated effects of COVID-19 on the future cash flow projections on the basis of significant assumptions as per the available information. As per the management, the Company has sufficient financing arrangements to fulfil its working capital requirements and necessary capital expenditure. Based on aforesaid assessment, Management believes that as per estimates made conservatively, the Company will continue as a going concern and will be able to discharge its liabilities and realise the carrying amount of its assets.

- 4 The figures for the corresponding previous periods have been regrouped/ reclassified wherever considered necessary to conform to the figures represented in the current period.
- 5 Company has received full amount of Share Warrant Money of Rs 130,00,000/- towards 6,50,000 Convertible Share Warrant of Rs 20/- each (including Premium of Rs.10/- each), from Preferential Allottee M/S Riser Holdings Private Limited, Vadodara, promoter group Company. The Board of Directors have allotted 650000 Equty Shares on conversion of fully paid up Warrants in to Equity Shares, having F.V. of Rs 10/- each, at premium of Rs 10/- each, to M/S Riser Holdings Private Limited, pursuant to Special Resolution approved in the 35th Annual General meeting of the Company held on 10th September, 2020.

- 1. We have reviewed the accompanying Statement of Unaudited Financial results of Jindal Hotels Limited ('the Company'), for the quarter ended 31st December, 2020 and the year to date results for the period from 1st April, 2020 to 31st December, 2020 ("The Statement") attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirement) Regulations, 2015, as amended (the "Listing Regulations").
- 2.
