### To Board of Directors of Jumbo Bag Limited

### Opinion

We have audited the accompanying standalone quarterly financial results of Jumbo Bag Limited for the quarter ended March 31, 2021 and the year to date results for the period April 1, 2020 to March 31, 2021, attached herewith, being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
