1. The outbreak of COVID-19 virus since the beginning of 2020 continues to spread across the globe including India. Due to this pandemic, the Central as well as the State Governments have declared a complete lockdown throughout the country till 3<sup>rd</sup> May, 2020, which was later on extended till 31<sup>st</sup> May, 2020.
2. Due to continuous lockdown throughout the country, the manufacturing operations at all plants of the Company is suspended except Rice Mill located in Dehri on Sone, Bihar.
3. The administrative office of the Company at Varanasi and Kolkata was closed due to lock down. However, all the employees have been allowed to work from home. The Company has started its partial operation from Registered Office and Head Office w.e.f. 8<sup>th</sup> June 2020 as allowed by the Government.
4. Current circumstances are extremely uncertain and the business landscape is fast changing and continuously evolving. Hence, it is not possible to estimate the full impact of COVID-19 on Company's business at this point of time.
5. The performance of the Company continues to be affected during the lock down period.
