### To The Board of Directors of Kalyani Steels Limited, Pune

- 1. We have reviewed the accompanying Statement of Consolidated Unaudited Financial Results of Kalyani Steels Limited ("the Parent") and its subsidiary (the Parent and its subsidiary together referred to as "the Group"), and its share of the net (loss) after tax and total comprehensive (loss) of its subsidiary for the quarter and nine months ended 31 December 2019 ("the Statement"), being submitted by the Parent pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended which includes one Joint Operation Company consolidated on a proportionate basis with Parent company ("the Statement").
