

The above unaudited Consolidated Financial Results of the Group for the quarter and nine months ended 31st December, 2021 have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meeting held on 14th February, 2022.

 The Statement has been prepared in accordance with companies (Indian Accounting Standards) Rule, 2015 (Ind AS) prescribed under section 133 of the Companies Act, 2013 and other recognised accounting practices and policies to the extent applicable.

3. The company has issued 20,305 Equity Shares under the ESOP scheme at an exercise price of Rs. 10 per equity share during the quarter ended 31st December, 2021.

The Group is predominantly engaged in the business of Pharmaceuticals, whose results are reviewed regularly by chief operating decision maker for making decisions about resource allocation and performance assessment. As such, there are no separate reporting segments as per Ind-AS 108.

The green field project of the Group under its foreign subsidiary - Kilitch Estro Biotech PLC, at Oromia Special Zone, Ethiopia, had started the commercial production of 5. Cephalosporins Injectables w.e.f 26th July 2021. The sales/revenue from the said project has commenced during the said quarter and are accordingly reflecting in the said results.

6. The Group continues to monitor the impact of Covid-19 on its business, including its impact on customers, supply-chain, employees and logistics. The Management has exercised due care and made reasonable judgements and estimates from internal and external sources of information including economic forecasts, inter alia, in determining carrying amounts of trade receivables, property, plant & equipment, inventories and other financial assets while preparing the financial results as of and for the quarter and nine months ended 31st December, 2021. The Group based on current estimates expects to recover the carrying amount of the above assets, net of provisions established.

In view of the uncertainties regarding the nature and duration of the ongoing COVID-19 Pandemic, we are unable to predict the future impact on our business operations. However, the Group will continue to closely monitor the situation and take appropriate measures in an attempt to mitigate any adverse impact on its
