#### INDEPENDENT REVIEW REPORT FOR THE QUARTER ENDED JUNE 30, 2019 FINANCIAL RESULTS

### To the Board of Directors of Kirloskar Ferrous Industries Limited

- We have reviewed the accompanying statement of unaudited financial results of Kirloskar Ferrous Industries Limited (the "Company") for the period ended June 30, 2019 ("the Statement"). This statement is the responsibility of the Company's Management and has been approved by the Board of Directors. - 2.
