**Opinion:**

We have audited the quarterly and yearly standalone financial results of Mohit Paper Mills Limited ("the Company") for the quarter and year ended 31<sup>st</sup> March, 2023 ("the statement") attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations")

**Basis for Opinion:**
