- 3 The financial statements have been prepared in compliance with Indian Accounting Standards (Ind AS).
- 4 The operation of the Company relates to only one primary segment viz., Iron Castings.
- The figures for the quarter ended 31<sup>st</sup> March 2022 are the balancing figures between audited figures in respect of the full financial year and the published year to date figures upto nine months ended 31<sup>st</sup> December 2021.
- 6 Previous year figures have been regrouped/rearranged wherever necessary.
- 7 The spread of COVID-19 has impacted global economic activity as has been witnessed in several countries. There have been severe disruptions in businesses in India during the Lock down period. The situation is evolving and the assessment of impact due to COVID-19 is a continuous process, given the uncertaintiles. Management has conducted the possible impact of known events arising from COVID-19 pandemic in the preparation of these financial results and has analysed events subsequent to 30<sup>th</sup> June 2022 and believes that there will not be any material effect on the carrying values of the assets and liabilities of the Company on the reporting date and there is no change in its ability to continue as a Going Concern.
