# Opinion

- 1. We have audited the quarterly financial results of Archidply Industries Limited for the quarter ended 31st March ,2022 and the year to date results for the period 1st April ,2021 to 31st March, 2022 and the Statement of Assets and Liabilities and the statement of Cash Flows as at and for the year ended on that date, attached herewith, being submitted by the company pursuant to the requirement of Regulation 33 and 52 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. read with SEBI circular No. CIR/CFD/FAC/62/2016 dated 5th July, 2016.
- 2. In our opinion and to the best of our information and according to the explanations given to us these quarterly financial results as well as the year to date results:
