Report on the audit of the Standalone Annual Financial Results

Opinion

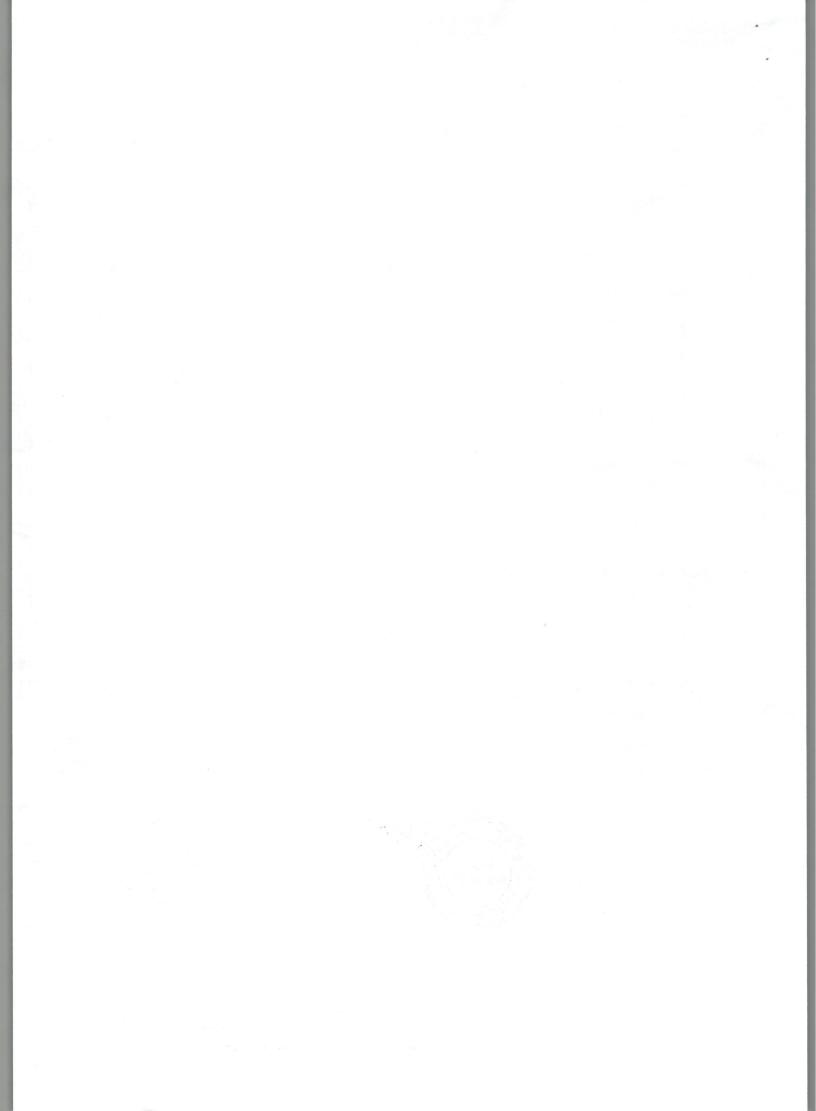
