We have reviewed the accompanying statement of unaudited standalone financial results ('the Statement') of Saboo Brothers Limited ('the Company') for the quarter ended 31 December 2022 and year to date results for the period from 01 April 2022 to 31 December 2022 attached herewith, being submitted by the Company pursuant to the requirements of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended. 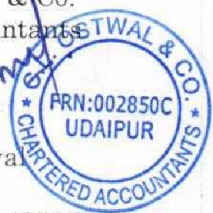
