The Statement include the results for the quarter ended 31.03.2023 and 31.03.2022 being the balancing figure of the audited figures in respect of the full financial year and the publised year to date figures upto the third quarter of the respective financial years, which were subject to limited review by the respective auditors.

Total Income for the Current Quarter is Rs.1166.71 Lakhs as compared to Rs.712.80 Lakhs for the Corresponding Quarter of the previous year and Total Income for the Financial year ended 31.03.2023 is at Rs.3710.66 Lakhs as Compared to Rs.2312.54 Lakhs of the Previous year.

The Profit (Loss) before tax for the Current Quarter is Rs.(49.99) Lakhs as compared to profit (Loss) of Rs.(44.46)
 Lakhs for the correspnding quarter of previous year. The Profit (Loss) before tax for the financial year ended 31.03.2023 is Rs. 41.73 Lakhs Compared to Rs.37.23 Lakhs for the Previous year.

The Profit (Loss) After tax for the Current Quarter is Rs.(55.77) Lakhs as compared to profit (Loss) of Rs.(16.83) Lakhs for the correspnding quarter of previous year. The Profit (Loss) After tax for the financial year ended 31.03.2023 is Rs.34.70 Lakhs as Compared to Profit (Loss) of Rs.30.79 Lakhs for the Previous year.

Opinion

We have audited the accompanying statement of quarterly and year to date standalone financial results of BSE Limited (the "Company") for the quarter and year ended March 31, 2023 ("Statement"), attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations").

In our opinion and to the best of our information and according to the explanations given to us, the Statement:

i. is presented in accordance with the requirements of the Listing Regulations in this regard; and

ii. gives a true and fair view in conformity with the applicable accounting standards and other accounting principles generally accepted in India, of the net profit, other comprehensive income and other financial information of the Company for the guarter and year ended March 31, 2023.

Basis for Opinion
