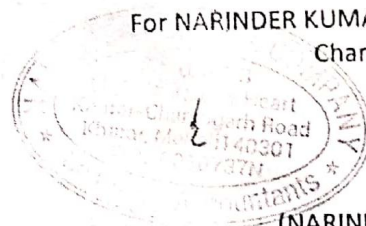
Review Report to Board of Directors of SGN Telecoms Limited.
