Independent Auditor's Review Report

To The Board of Directors, Sundaram Brake Linings Limited

Re: Limited Review Report for the quarter and nine months ended 31 December 2021

- 1. We have reviewed the accompanying Statement of unaudited financial results of Sundaram Brake Linings Limited (the "Company") for the quarter and nine months ended 31 December 2021 ("the Statement") being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
