#### Notes:

The above Cash Flow Statement has been prepared under the "Indirect Method" as set out in the Indian Accounting Standard (Ind AS-7) - Statement of Cash Flow.



#### Notes

- 1. The above results prepared and presented in pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 have been reviewed by the Audit Committee in its meeting held on June 19, 2021 and were approved by the Board of Directors in its meeting held on June 19, 2021. The statutory auditors of the Company have expressed an unqualified opinion on these Financial Results.
- 2. The figures of the quarters ended March 31,2021 are the balancing figures between the audited figures in respect of the full financial year and published year to date figures up to the third quarter of the relevant financial year.

#### 3. Exceptional Items

The Company has invested in Non-convertible Bonds of Lakshmi Vilas Bank Ltd, due to defaults in principal and interest repayment by the respective Bank, and as per Reserve Bank of India , the Company has written off the investments, which are shown as an exceptional item in the statement of profit and loss.

- 4. Consequent to the outbreak of COVID-19 pandemic, the Indian government had announced lockdown in March 2020. Subsequently, the lockdown has been lifted by the government in a phased manner outside specified containment zones. The extent to which the COVID-19 pandemic, including the current second wave that has significantly increased the number of cases in India, may continue to impact the Company's performance, will depend on ongoing and future developments, which are uncertain, including among other things, any new information concerning the severity of the COVID-19 pandemic and any action to contain its spread or mitigate its impact whether government mandated or elected by us.
- 5. The Company has only one reportable Segment viz. "Shares & Securities".
- 6. In pursuance of Section 115BAA of the Income Tax Act, 1961 announced by Government of India through Taxation Laws (Amendment) Ordinance, 2019, the Company has an irrecovable option of shifting to a lower tax rate and simultaneously forgo certain tax incentives including loss of accumulated MAT Credit. The Company has exercised this option in the current year.
- 7. The above financial results have been prepared in accordance with the Indian Accounting Standards (Refered to as "Ind AS") As prescribed under section 133 of the Companies Act, 2013 read with companies (Indian Accounting Standards) Rules as amended from time to time.
- 8. Previous periods' figures have been regrouped and recomputed, wherever necessary.


