The consolidated unaudited financial results includes the Company's share of net loss after tax of Rs. 0.27 lacs and Rs. 0.75 lacs and total comprehensive loss of Rs. 0.27 lacs and Rs. 0.75 lacs for the quarter and nine months ended 31st December, 2022 respectively as considered in the consolidated unaudited financial results, in respect of two joint ventures, based on their interim financial results which have not been reviewed by their auditors. According to the information and explanations given to us by the Management, these interim financial results are not material to the Company.
