Please note that last date for submission of financial results for quarter and year ended 31st March, 2020 is 30th June, 2020 as per revised timelines for submission of compliance filings under Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 due to COVID-19.

Further note that due to the unprecedented situations arising out of COVID-19 pandemic, our office has opened from 8th June, 2020 with limited number of staffs. There are no train services available till now. Most of our staffs are coming by train due to that they are unable to attend the office. Under such circumstances it will be impossible for us to file financial result on or before 31st August, 2020. All the circumstances are beyond our control.

The extension of 30 days from 30th May to 30 June, 2020 was made on 20th March, 2020 by SEBI when the lockdown was proposed for 21 days, from 24th March, 2020 which finally went upto 60 days and same is continuing in part even today. All government agencies namely GST, Income Tax, Custom, Bank etc. has extended their due dates by 3 months or more then why you cannot extend by even 2 months.
