- 1. The Company is engaged in the business of manufacturing, trading and sale of a range of refractories and is having its manufacturing facilities located in India. The performance of the company is assessed and reviewed by the Chief Operating Decision Maker ('CODM') as a single operating segment and accordingly manufacture, trading and sale of refractories is the only operating segment.
- 2. Post applicability of Goods and Services Tax ('GST') with effect from July 1, 2017, revenue from operations is disclosed net of GST. Accordingly the revenue from operations for quarter ended June 30,2018, September 30, 2018, and nine months ended September 30, 2018 are exclusive of GST whereas the amounts for the nine months ended September 30, 2017 and full year ended December 31, 2017 includes applicable excise duty and hence not comparable.
- 3. These unaudited financial results have been reviewed by the Audit Committee and approved by the Board of Directors at their meeting held on November 1,2018.
- 4. These unaudited financial results have been subjected to limited review by the statutory auditors of the company who have expressed an unqualified/unmodified conclusion on these

Based on our review conducted as above, nothing has come to our attention that causes us to believe that the Statement has not been prepared in all material respects in accordance with the applicable Accounting Standards prescribed under Section 133 of the Companies Act, 2013 and other recognised accounting practices and policies, and has not disclosed the information required to be disclosed in terms of Regulation 33 of the Listing Regulations, 2015 including the manner in which it is to be disclosed, or that it contains any material misstatement
