We have reviewed the unaudited consolidated financial results of AYM Syntex Limited (the "Parent"), its subsidiary (the parent and its subsidiary hereinafter referred to as the "Group") (refer Note 1 in the unaudited consolidated financial results) for the quarter ended December 31, 2022 and the year to date results for the period April 1, 2022 to December 31, 2022 which are included in the accompanying 'Statement of Unaudited Consolidated Financial Results for the Quarter and Nine months ended December 31, 2022 (the "Statement").
