Report on the audit of the Annual Financial Results

Opinion

We have audited the accompanying annual financial results of BCC FUBA INDIA LIMITED (*"the Company"*) for the year ended 31 March 2021, attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (*"Listing Regulations"*).

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid annual financial results:


