 - [2] The figures for the quarter ended 31st March, 2018 are the balancing figures between the audited figures in respect of the full financial year ended 31st March, 2018 and the published year to date figures upto the third quarter ended 31st December, 2017.
 - [3] This statement has been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 (Ind AS) prescribed under Section 133 of the Companies Act, 2013 and other recognized accounting practices and policiesn to the extent applicable.
 - [4] The Company operates in a single segment and in line with Ind AS 108 "Operating Segments", the operation of the Company fall under "Manufacturing of Castings" business which is considered to be the only reportable business segment.
 - [5] In accordance with the requirements of Ind AS, revenue for the quarter ended 30th June 2018 and 31st March 2018 is net of Goods and Service Tax (GST). However, revenue for the quarter ended 30th June 2017 is inclusive of excise duty and hence not directly comparable with revenue of other guarters.
 - [6] The figures of previous quarters / year are reclassified, regrouped and rearranged wherever necessary so as to make them comparable with current period's figures.
 - [7] The Statutory auditors of the Company have conducted a limited review of the above unaudited financial results for the quarter ended June 30, 2018 as per Regulation 33 of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015.
